**NOTICE OF FORMAL HEARING**

PLEASE TAKE NOTICE that the Public Employment Relations Board will conduct a hearing on the unfair practice complaint in this case.

The hearing will be held on October 12 through 15, 2021, starting at 10:00 a.m. At that time, the parties shall have the right to appear themselves or by counsel or other representative; to call, examine, and cross examine witnesses; and to introduce documentary and other evidence regarding the issues.

To comply with public health guidelines for preventing community spread of COVID-19, the hearing will be conducted remotely via PERB's Webex (or a similar) platform. Via this platform, each party and its representative or representatives has an opportunity to participate and to hear the entire proceeding while it is taking place and to observe exhibits. Members of the public may observe the hearing through electronic means. As the presiding officer, the undersigned will satisfy all requirements of the Americans with Disabilities Act and the Unruh Civil Rights Act.

If either party intends to call a witness who does not proficiently speak or understand the English language and who will request language assistance, please notify the ALJ assigned to the case immediately in writing so that arrangements for an interpreter can be made. (Gov. Code, § 11435.05 et seq.)
